

**Waiver of Liability, Assumption of Risk and Indemnity Agreement  
GPAA of Northern Nevada Reno, Nevada**

In consideration of being permitted to enter on to claims managed, leased or owned by GPAA of Northern Nevada Reno. I, for myself, my heirs, personal representatives and assigns, release, waive, discharge and covenant not to sue GPAA of Northern Nevada Reno, its subsidiaries and affiliates, agents, directors, employees, managers, and officers for and from liability from any and all claims resulting in accident, damages, personal injury (including death) and property loss arising from or relating to my entry onto the properties which comprise the GPAA of Northern Nevada Reno, including any private lands and unpatented mining claims on Federal public lands which are managed, leased or owned by GPAA of Northern Nevada Reno.

I acknowledge that certain parts of the properties which comprise the GPAA of Northern Nevada Reno are the sites of rugged terrain and historic mineral exploration and mining activity and that entry onto such parts of the GPAA of Northern Nevada Reno owned, leased or managed properties carry certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries or damage to property. I acknowledge that the properties which comprise the GPAA of Northern Nevada Reno vary in terrain, topography and vegetation and contain manmade and natural features and structures which are difficult to access and which may require strenuous physical exertion. I also acknowledge that the GPAA of Northern Nevada Reno Properties are remote and that there is no ambulance service or medical service near the GPAA of Northern Nevada Reno Properties. I agree to comply with all safety regulations and rules and access restrictions of GPAA of Northern Nevada Reno.

I have read the preceding paragraphs and I appreciate, know and understand these and other risks that are inherent in entry onto the properties which comprise the GPAA of Northern Nevada Reno properties. I acknowledge and covenant that my entry onto the properties and my participation in any field examinations, investigations or trips is voluntary and that I knowingly assume all of the risks described in this Waiver. **I HEREBY ASSUME ALL THE RISKS ASSOCIATED WITH MY ENTRY ONTO THE PROPERTIES WHICH COMPRISE THE GPAA OF NORTHERN NEVADA RENO PROPERTIES.**

I agree to hold harmless GPAA of Northern Nevada Reno, its subsidiaries and its affiliates from and against any and all actions, claims, costs, expenses, damages, liabilities, procedures and suits, including any attorney's fees or costs, asserted or brought as a result of my entry onto the properties which comprise the GPAA of Northern Nevada Reno properties. **I HEREBY ASSUME ALL THE RISKS ASSOCIATED WITH MY ENTRY ONTO THE PROPERTIES WHICH COMPRISE THE GPAA OF NORTHERN NEVADA RENO PROPERTIES.** I acknowledge that GPAA of Northern Nevada Reno. and its affiliates are **NOT** responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of GPAA of Northern Nevada Reno, and its affiliates. I expressly acknowledge and agree that this Waiver and my assumption of the risks described in this Waiver are intended to be as broad and as inclusive as is permitted under the laws of the State of Nevada and the laws of the State of California and that if any portion of this Waiver is held to be invalid, I agree that the balance of this Waiver shall continue to be in full force and legal effect.

I have read this Waiver, fully understand its terms and understand that I may be giving up substantial rights, including my right to sue GPAA of Northern Nevada Reno. and its affiliates. I acknowledge and covenant that I have signed this Waiver freely and voluntarily and intend by my signature to grant a complete and unconditional release of all liability to the full extent allowed under the laws of the State of Nevada and the laws of the State of California.

I acknowledge and covenant that I am over age eighteen (18) years and that I have full legal and mental capacity to read, acknowledge, understand and execute and deliver this Waiver. **I CERTIFY THAT I HAVE READ THIS DOCUMENT AND THAT I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS ASSUMPTION AND RELEASE AND WAIVER IS A CONTRACT THAT CAUSES ME TO SURRENDER VALUABLE LEGAL RIGHTS. I FREELY, KNOWINGLY AND VOLUNTARILY AGREE TO SUCH SURRENDER IN RETURN FOR THE BENEFITS AND OPPORTUNITY TO ENTER ONTO THE PROPERTIES WHICH COMPRISE THE GPAA OF NORTHERN NEVADA RENO.**
